All that piece, parcel, or lot of land situate, lying, and being in Gantt Township, Greenville County, State of South Carolina, on the northern side of Spring Street and being shown as "Ethel J. Rodgers" lot on plat of Property of C. E. and Louise McKinney prepared by C. O. Riddle, dated July 18, 1956, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northern side of Spring Street at the southwestern corner of said McKinney property and running thence along said Street S. 81-44 W. 92.6 feet to an iron pin; thence along the line of property now owned by Crawford N. 21-08 E. 275 feet more or less to an iron pin; thence S. 68-10 E. 81.6 feet to an iron pin; thence along McKinney line S. 21-08 W. 225 feet to the point of BEGINNING.

The above described property is a portion of a 8.45 acre tract heretofore deeded to Ethel J. Rodgers by deed of A. H.
