Hartley, Jr. and Carolyn P. Hartley, their heirs and assigns, forever,

All that certain lot of land lying in the State of South Carolina, County of Greenville, City of Greenville, on the northwestern side of Hialeah Road, shown as Lot 368 on a plat of Section B-1 of Gower Estates, made by R. K. Campbell, Surveyor, on April 12, 1962 and recorded in the R.M.C. Office for Greenville County in Plat Book XX at page 107 and having, according to said plat, the following courses and distances:

BEGINNING at an iron pin on the northwestern side of Hialeah Road at the joint front corner of Lots 367 and 368; thence along the line of Lot 367, N. 69-08 W. 133.1 feet to an iron pin; thence N. 2-35 E. 100 feet to an iron pin; thence with the line of Lot 369, S. 87-25 E. 171.5 feet to an iron pin on Hialeah Road; thence with the curve of Hialeah Road, the chord of which is S. 14-32 W. 75 feet to an iron pin; thence still with the curve of Hialeah Road, the chord being S. 25-49 W. 75 feet to the point of beginning.

This is the identical property conveyed to the Grantors hereby by deed of Bobby R. David and Betty H. David, dated May 7, 1970, and recorded in the R.M.C. Office for Greenville County in Deed Book 890, at page 133.
