Jan T. Stover, his heirs and assigns forever:

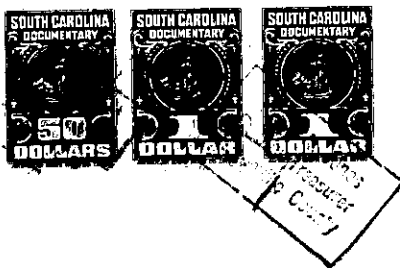
