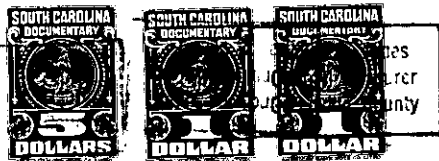
in consideration of Three Thousand Five Hundred and No/100 (\$3,500.00) ----- Dollars,
