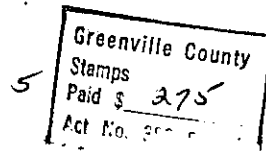
All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northerly side of Queen Ann Road, near the City of Greenville, S. C., being known and designated as Lot No. 29 on plat of Foxcroft, Section I, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Queen Ann Road, said pin being the joint front corner of Lots 28 and 29 and running thence with the common line of said lots N 3-49 W 165 feet to an iron pin, the joint rear corner of Lots 28 and 29; thence N 86-11 E 130 feet to an iron pin, joint rear corner of Lots 29 and 30; thence with the common line of said lots S 3-49 E 165 feet to an iron pin on the northerly side of Queen Ann Road; thence with the northerly side of Queen Ann Road S 86-11 W 130 feet to an iron pin, the point of beginning.

This conveyance is subject to a 10 foot drainage easement and a 25 foot sewer easement and to all restrictions, setback lines, roadways, easements and right of ways, if any, affecting the above described property.
