KNOW ALL MEN BY THESE PRESENTS That ABNEY MILLS

a corporation organized and existing under the laws of the State of South Carolina and having its principal place of business at Greenwood in the State of South Carolina, for and in consideration of the

sum of ONE AND NO/100THS- - - - - dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain/sell and release unto JANET BAILEY BENNETT quitclaim

All that piece, parcel or strip of land situate, lying and being on the Southern side of Pendleton Street in or near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as the westerly one-half of Norwood Street (unopened) as shown on a plat entitled "Plat No. 1, Brandon Subdivision", prepared by H. O. Jones, dated April, 1913, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book C at at page 76, and having the following metes and bounds:

BEGINNING at an iron pin on the southern side of Pendleton Street at the northeastern corner of Lot No. 23 and running thence with the line of Lots Nos. 23 and 22 S. 22-45 W. 225 feet to an iron pin; thence S. 70-41 E. 22½ feet, more or less, to a point in the center of Norwood Street; thence with the center line of Norwood Street N. 22-45 E. 225 feet, more or less, to a point on the southern side of Pendleton Street; thence with the southern side of Pendleton Street N. 70-41 W. 22½ feet, more or less, to the point of beginning.

It is the intent of the grantor herein to convey to the grantee herein whatever interest it may have in and to the western one-half of Norwood Street adjacent to Lots Nos. 23 and 22 as shown on the plat referred to above.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, her successors, heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and her ~~successors, heirs and assigns~~ heirs and assigns, against itself and its successors, and against every person who may lawfully claim the same or any part thereof.
