in consideration of One thousand six hundred fifty and no/100----(\$1,650.00)-----Dollars,

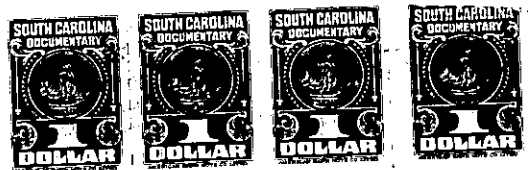
