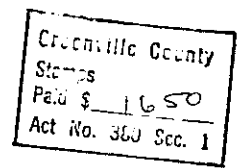
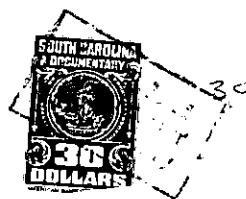

All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the southeastern side of Parkins Mill Road, being known and designated as Lot No. 2, Block H, Section 4, East Highlands Estates, a Plat of which was made by Dalton & Neves, January, 1941, and recorded in the R. M. C. Office for Greenville County, in Plat Book K, at Page 78, and having according to said Plat, the following metes and bounds, to-wit:
