unto Donna G. Ballard, her heirs and assigns forever:

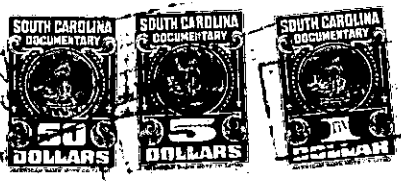
