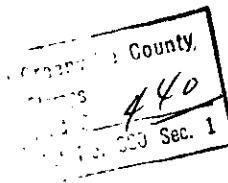
KNOW ALL MEN BY THESE PRESENTS, that Glenn Henson

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Revis Morris, his heirs and assigns forever, all that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, South Carolina, shown and designated as Two (2) acres on plat made for Revis Morris by W.N. Willis, Engineers, from field survey by S.D. Atkins, made September 21, 1971, showing courses and distances as follows:

Beginning on an iron pin in North line of driveway leading from Goodjoin Road to Revis Morris home, at a point 600 feet from Goodjoin Road, and running South 14-30 West 210 feet to an iron pin; thence North 75-30 West 420 feet to an iron pin; thence North 14-30 East 210 feet to an iron pin in line of driveway; thence with North line of driveway South 75-30 East 420 feet to the beginning.
