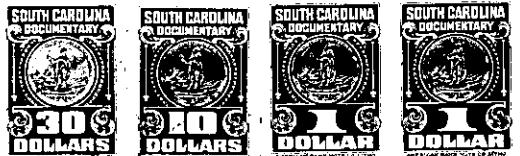
KNOW ALL MEN BY THESE PRESENTS, that Harold Kenneth Davis and William L. Wylie, Jr. -----
