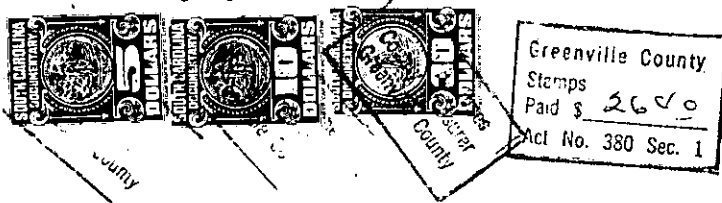

BEGINNING at an iron pin on the northeasterly side of Elizabeth Drive, joint front corner of Lots Nos. 217 and 218, and running thence with the joint lines of said lots, N. 56-30 E. 201.7 feet to an iron pin; running thence S. 33-30 E. 100 feet to an iron pin, joint rear corner of Lots Nos. 218 and 219; running thence with the lines of said lots, S. 56-30 W. 200 feet to an iron pin on the northeasterly side of Elizabeth Drive; thence with the north-easterly side of Elizabeth Drive, N. 33-30 W. 60 feet to an iron pin; thence continuing with the northeasterly side of said Drive, N. 36-00 W. 40 feet to the point of BEGINNING.
