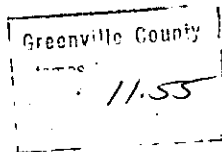
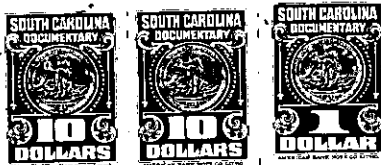
In consideration of Ten Thousand Three Hundred and No/100 (\$10,300.00) ----- Dollars,
