the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Bruce R. Duncan and Janice H. Duncan, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the northwesterly side of a county road in the County of Greenville, State of South Carolina, containing 25.35 acres according to a plat of property of Bruce Duncan prepared by Terry T.
