in consideration of Seven Hundred Fifty and no/100 ----- (\$750.00) ----- Dollars,

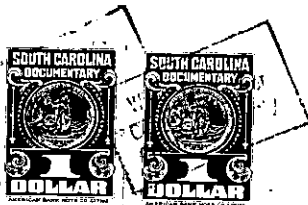
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. H. Alford, his heirs and assigns forever

All that piece, parcel, or lot of land in the County of Greenville, State of South Carolina, situate, lying and being on the northern side of Bennetts Bridge Road and having, according to a recent survey entitled "Survey for W. H. Alford" prepared by Campbell and Clarkson, SCRLS dated August 13, 1971, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the approximate center of Bennetts Bridge Road, joint corner of the within described property and that now formerly of Smith, and from thence at the approximate center of Bennetts Bridge Road S. 63-55 W. 1048.3 feet to an iron pin; thence continuing with the approximate center of Bennetts Bridge Road S. 63-15 W. 259.4 feet to a point in the approximate center of Bennetts Bridge Road, joint corner of the within described property and that now or formerly of Bayne; thence with the common line of the Bayne property N. 17-30 W. 47 feet to an iron pin; thence N. 66-58 E. 154.7 feet to an iron pin; thence N. 66-30 E. 396 feet to an iron pin; thence N. 60-15 E. 239 feet to an iron pin; thence N. 56-30 E. 297 feet to an iron pin; thence N. 69-30 E. 230 feet to an old iron pin (axle); thence S. 13-00 E. 50 feet to the point of beginning.

This is a portion of that same property conveyed to the Grantor herein by deed recorded in the RMC Office for Greenville County in Deed Book 749 at Page 531.

It is the intent of the Grantor herein by this deed to transfer to the Grantee herein a strip of land lying north of Bennetts Bridge Road between Bennetts Bridge Road and a 43.90 acre tract being purchased by the within Grantor from the Estate of Wallace Edsil Reid.
