8/27ths, their heirs and assigns forever:

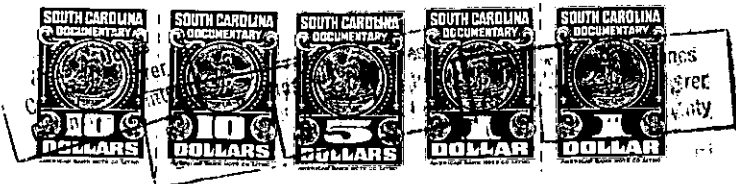
