ALL THAT CERTAIN PIECE, PARCEL OR LOT OF GROUND, together with all the buildings and improvements thereon, lying in Paris Mountain Township, County of Greenville, State of South Carolina, fronting on the west side of Melody Drive; according to a survey and map by R.B. Bruce, Surveyor, dated December 22, 1970 (Subdivision Plat registered in Plat Book CCC, page 71, Records of R.M.C., Greenville County, S.C.); said property being more particularly described as follows:

BEGINNING at a point on the West margin of Melody Drive, the Southeast corner of said lot, and running North 85 degrees 30 minutes West, One Hundred thirty seven and nine tenths (137.9') feet to a point; then North 30 degrees 30 minutes West, Seventy four (74.0') feet to a point; then North 11 degrees 25 minutes East, Twenty five (25.0') feet to a point; then South 85 degrees 30 minutes East, One hundred seventy seven and six tenths (177.6') feet to a point on the West margin of Melody Drive, the Northeast corner of said Lot; then South 4 degrees 30 minutes West, Eighty five (85.0') feet, along the West margin of Melody Drive to the point of beginning.
