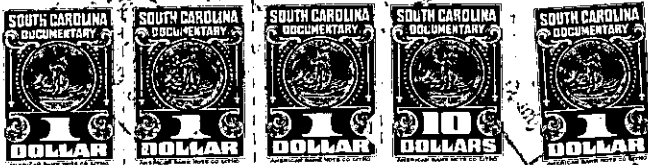
KNOW ALL MEN BY THESE PRESENTS, that C. S. Willingham and Robert H. Freeland -----
