(\$9,000.00) -----Dollars,

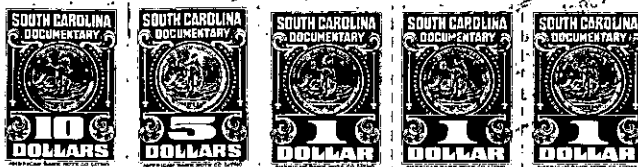
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and  
release unto BETH ISRAEL CEMETERY ASSOCIATION, its successors and assigns forever:

ALL that piece, parcel, or lot of land in the County of Greenville, State  
of South Carolina, being shown as "Property of Beth Israel Cemetery  
Association", on plat by Jones Engineering Service, dated February 16,  
1971, and having, according to said plat, the following metes and bounds,  
to-wit:

BEGINNING at an iron pin in the joint line of property of Graceland  
Cemetery and Beth Israel Cemetery Association and running thence with  
the joint line of said property, N 64-21 E 20 feet to an iron pin; thence  
with the line of the property of Graceland Cemetery, S 24-14 E 108 feet  
to an iron pin; thence S 65-46 W 20 feet to an iron pin; thence N 24-14 W  
107.7 feet to the point of beginning.

Together with an easement or right-of-way unto the grantee, its successors  
and assigns, over and upon the roads of the grantor located in Graceland  
Cemetery and the approaches thereto, extending from any public road to  
the property of the grantee for purposes of ingress and egress, which

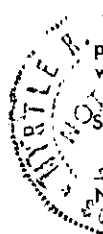
