unto Ronald C. Bieker and Jeanne R. Bieker, their heirs and assigns forever:

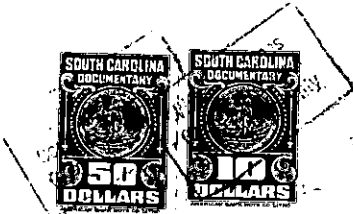
