KNOW ALL MEN BY THESE PRESENTS, that BENJAMIN F. BROWN and BARBARA W. BROWN

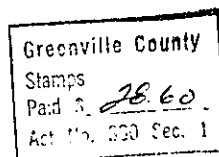
in consideration of TWENTY SIX THOUSAND (\$26,000.00)-----Dollars
