the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto THOMAS L. MILLER, JR. AND DAPHNE MILLER, THEIR HEIRS AND ASSIGNS FOREVER:

ALL that piece, parcel or lot of land in O'Neal Township, County of Greenville, State of South Carolina, located about 4 miles North from Greer, S.C. on the Northern side of Lake Cunningham, and the Southern side of a new road and being shown as all of lot number TEN (10) on plat of property made for Lee Styles by John A. Simmons, Surveyor, dated June 23, 1962 and having the following metes and bounds, to wit: BEGINNING at an iron pin on the southern side of a New Road at the joint front corner of lots 10 and 11 and running thence S. 13-04 W. 179.5 feet to an iron pin on the Northern side of said Lake; thence S. 59-10 E. 52.5 feet along the said lake to an iron pin at the joint rear corner of lots 9 and 10; thence N. 13-04 E. 182.2 feet as the common line of lots 9 and 10 to an iron pin on said road, joint front corner of said lots; thence N. 62-05 W. 51.7 feet along said road to the beginning corner. 286-537.7-1-44

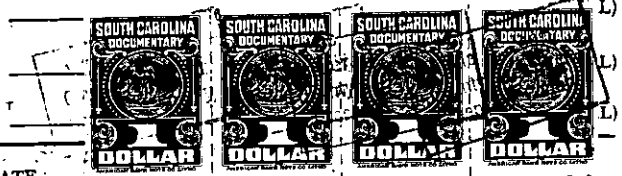
