KNOW ALL MEN BY THESE PRESENTS, that We, Milton R. Long and Versa M. Long

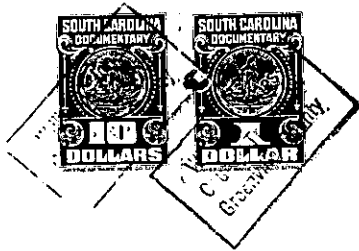
in consideration of Five Thousand Five Hundred and No/100-----(\$5,500.00)---- Dollars,
