KNOW ALL MEN BY THESE PRESENTS, that we, Felton L. Petty and Oma J. Petty,

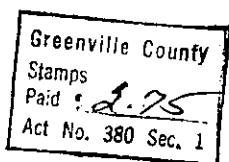
in consideration of Two Thousand Five Hundred (\$2,500.00) ----- Dollars,
