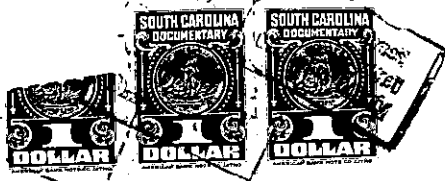

ALL that lot of land in the State of South Carolina, County of Greenville, in the Town of Fountain Inn, located on the northerly side of Woodside Avenue and being a portion of the property as shown on a plat of property of Jones and Gault, prepared by Carolina Engineering & Surveying Company, recorded in Plat Book UUU, at page 111 and having, according to a more recent survey prepared by John E. Woods, Surveyor, dated October, 18, 1971, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly edge of Woodside Avenue, said pin being located 125 feet southeast of the western-most corner of the original tract as shown on the aforesaid plat and running thence N. 49-38 E. 153.2 feet to an iron pin; thence S. 37-48 E. 74 feet to an iron pin on the northwesterly edge of Sims Street; thence along the edge of said street, S. 35-30 W. 132.5 feet to an iron pin; thence S. 88-18 W. 30.2 feet to an iron pin on the northeasterly edge of Woodside Avenue; thence along the edge of said Avenue, N. 38-54 W. 87.45 feet to the point of beginning.
