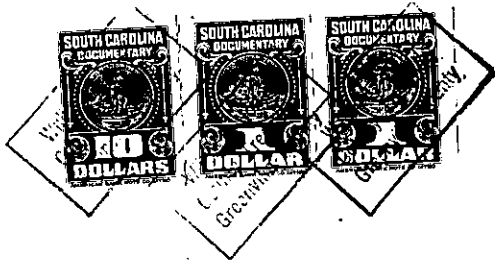
KNOW ALL MEN BY THESE PRESENTS, that WE, Paul W. Webb, Jr. and Sarah B. Webb,
