unto WACO F. CHILDERS, JR., his heirs and assigns;

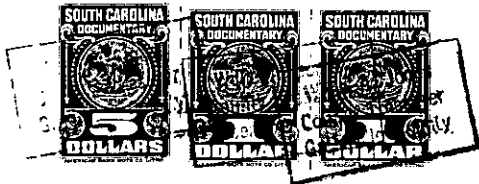

BEGINNING at an iron pin on the Northerly side of Neal Circle, joint front corner Lots 37 and 38, and running thence N. 10-50 W. 100 feet to an iron pin, joint rear corner Lots 37 and 38; thence S. 79-10 W. 80 feet to an iron pin; thence S. 10-50 E. 100 feet to an iron pin on the Northerly side of Neal Circle; thence along the Northerly side of Neal Circle, N. 79-10 E. 80 feet to an iron pin, the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.
