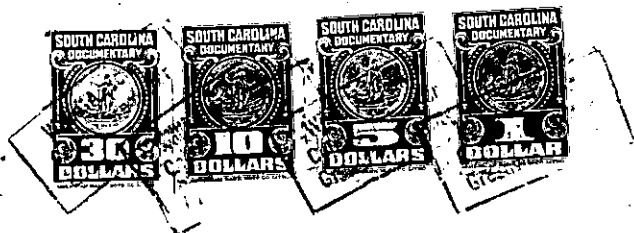
in consideration of Twenty-three Thousand (\$23,000.00) Dollars,
