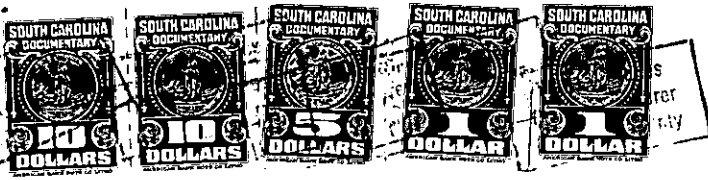
KNOW ALL MEN BY THESE PRESENTS, that Virginia A. Coleman
