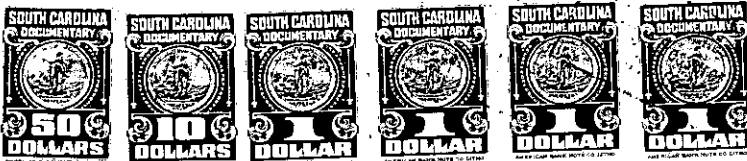
KNOW ALL MEN BY THESE PRESENTS, that we, James M. Fitzgibbons and Nancy S. Fitzgibbons,

All that certain piece, parcel or lot of land situate lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 59 of a subdivision known as Del Norte Estates according to a plat thereof prepared by Piedmont Engineers & Architects, dated August 28, 1968, and recorded in the R. M. C. Office for Greenville County in Plat Book WWV, at Page 32 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Great Glenn Road at the joint front corner of Lots 59 and 60 and running thence with the joint line of said lots, S. 70-09 W. 147.9 feet to an iron pin in the line of Lot 66; running thence with the line of Lot 66, S. 21-27 E. 128.0 feet to an iron pin; running thence N. 83-05 E. 75.3 feet to an iron pin at the corner of a future road; running thence with the line of said future road, N. 9-49 E. 100.5 feet to an iron pin on the western side of the turnaround of Great Glenn Road; running thence with the curvature of said turnaround, the chord of which is N. 0-38 W. 63.3 feet to the point of beginning.
