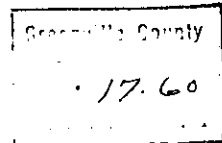
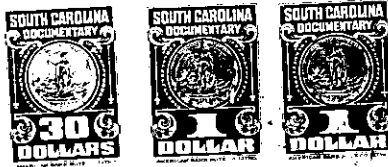
Aileen Greene, her heirs and assigns, forever:

BEGINNING at a stake on Lavinia Avenue at the joint corner of Lots 29 and 30 and running thence N. 21-45 W. with Lavinia Avenue 60 feet to a stake at joint corners of Lots 30 and 31 and running thence N. 80 E. with said joint lines 155 feet to a stake on a 10-foot alley; thence with said alley, S. 21-45 E. 60 feet to a stake at joint corners of Lots 29 and 30; thence with said joint lines, S. 80 W. 155 feet to a stake at beginning corner.
