WALTER G. VAUGHN AND ARTEZ C. VAUGHN, THEIR HEIRS AND ASSIGNS, FOREVER:

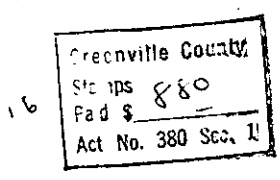
