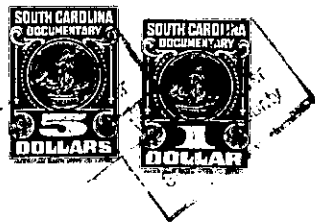
in consideration of **Two Thousand Nine Hundred Forty (\$2,940.00)** Dollars,
