the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Robert Allen and Octavia N. Allen, Their Heirs And Assigns,

LOT NO. 65 AND A NORTHERN PORTION OF LOT NO. 64

ALL that lot of land in the County of Greenville, State of South Carolina, being all of Lot No. 65, and a Northern portion of Lot No. 64 of Glendale Heights Subdivision, recorded in Plat Book KK at Page 143, of the R. M. C. Office for Greenville County, South Carolina; and having according to said Plat and a recent survey by C. C. Jones, Engineer, August 8, 1960, the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the East side of Knox Street, the front joint corner of Lots 65 and 66; thence with the joint line of said Lots No. 83-15 E. 130 feet to an iron pin, corner of Lot No. 31; thence with the rear line of Lots 31 and 32, S. 6-45 E. 87.5 feet to an iron pin; thence with a new line through Lot No. 64, S. 83-15 W. 130 feet to an iron pin on the East side of Knox Street; thence with the East side of said Knox Street, N. 6-45 W. 87.5 feet to the beginning corner.

AND

LOT NO. 66

ALL that certain lot of land lying in the State of South Carolina, County of Greenville, at the Southeastern corner of Knox Street and Driver Avenue shown as Lot No. 66 on a Plat of Glendale Heights, recorded in the R. M. C. Office for Greenville County in Plat Book KK at Page 143, and being further described as follows:

BEGINNING at an iron pin at the southwestern corner of Driver Avenue and Knox Street and running thence with the eastern side of Knox Street S. 6-45 E. 50 feet to an iron pin at the corner of Lot 65; thence with the line of Lot 65 N. 83-15 E. 130 feet to an iron pin at the corner of Lot 30 N. 6-45 W. 70 feet to an iron pin on Driver Avenue; thence along the southern side of Driver Avenue S. 83-15 W. 110 feet to an iron pin at the corner of Knox Street; thence along the curve of the intersection of Knox Street and Driver Avenue, the chord of which is S. 38-15 W. 28.3 feet to the beginning corner, being the same property conveyed to Earl K. Bentley by Deed recorded in Deed Book 733 at Page 241.

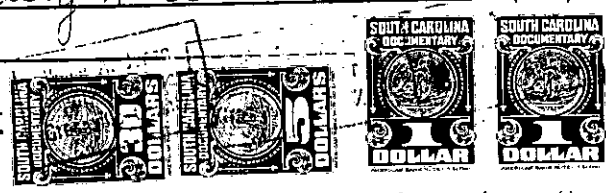
