the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Susie Bennett Young, her heirs and assigns forever, the following described property, to-wit:

All that piece, parcel or lot of land situate, lying and being in the Town of Taylors, Chick Springs Township, Greenville County, State of South Carolina, and being more particularly described according to a plat entitled "Survey for P.A. and Mattie Bennett Estate, Taylors, South Carolina", made by Carolina Surveying Company, the same being designated as Lot No. 11 on plat above referred to, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the side of a proposed road which point is 735.6 feet east of the intersection of a proposed road and a County Road and running thence S. 1-40 E. 539.5 feet to an iron pin in the C.W. Orvin line; thence with the C.W. Orvin property as the line N. 51-12 E. 112.7 feet to an iron pin at the corner of Burlington Industries, Inc., property; thence N. 1-40 W. 407.2 feet to an iron pin on the south side of a proposed road; thence with the south side of said proposed road N. 56-00 W. 110 feet to an iron pin, the joint front corners of Lots Nos. 10 and 11, the point of beginning, and containing one acre, more or less.
