the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Eustace E. Bennett, as Trustee for Carrie E. Bennett,

All that piece, parcel or lot of land situate, lying and being in the Town of Taylors, Chick Springs Township, Greenville, County, State of South Carolina, and being more particularly described according to a plat entitled, "Survey for P.A. and Mattie Bennett Estate, Taylors, South Carolina", made by Carolina Surveying Company, the same being designated as Lot No. 7, on plat above referred to, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on a proposed road at the joint front corners of Lots 6 and 7, which point is 315.6 feet east of the intersection of the proposed road and a County Road, and running thence S. 1-40 E. 645.9 feet to a point in the center of Marrow Bone Creek; thence with the center of Marrow Bone Creek as the line S. 83-10 E. 17.4 feet to a point in the center of Marrow Bone Creek; thence continuing with the center of Marrow Bone Creek as the line S. 43-15 E. 100.9 feet to a point in the center of Marrow Bone Creek; thence continuing with the center of Marrow Bone Creek as the line N. 67-42 E. 1.3 feet to a point in the center of Marrow Bone Creek; thence N. 1-40 W. 662.3 feet to an iron pin on the south side of a proposed road; thence with the south side of a proposed road as the line N. 56-00 E. 105 feet to an iron pin at the joint front corners of of Lots 6 and 7, the point of beginning and containing 1.3 acres, more or less.

This deed is made subject to any restrictions, easements and rights-of-way that may appear of record and/or on the recorded plat and/or on the premises.

This is a portion of the same property conveyed to the Grantor by heirs of Mattie Bennett by deed being recorded simultaneous herewith in Deed Book 932, at Page 365.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
