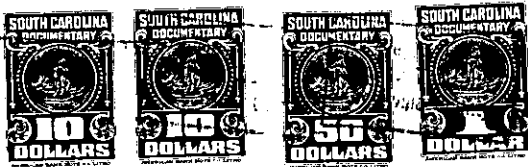
LESLIE E. MILLS, JR. AND EVELYN R. MILLS, THEIR HEIRS AND ASSIGNS, FOREVER:
