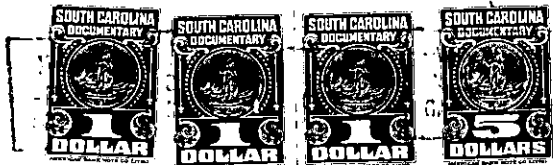
WILLA MOTE, his heirs and assigns forever:
