James F. Pinley, his heirs & assigns, forever:

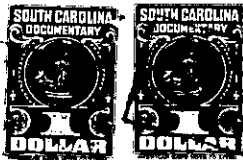
ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in Gantt Township, being known as Lot 75 Gantt Drive as shown on a plat of Brookwood recorded in Plat Book "BB" at Page 27, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin on Gantt Drive at joint front corners of Lots 76 and 75, as shown on recorded Plat, and running thence 100 feet with the line of said Drive to an iron pin at joint front corners of Lots 75 and 74; running thence 165 feet with the side line of Lot 74 to an iron pin at joint rear corners of Lots 74, 75, 60 and 61; running thence 100 feet with the rear line of Lot 60 to an iron pin at joint rear corners of Lots 59, 60, 75 and 76; running thence 165 feet with the side line of Lot 76 to the iron pin at joint front corners of Lots 75 and 76 on Gantt Drive, the point of beginning.

This is the same property conveyed to H. W. Fore from Belle Hardin Gantt and recorded in Book 538 of Deeds, Page 299, November 8, 1955. Also, this is the same property conveyed by Aubrey C. Fore, Individually and as Executrix of the Estate of H. W. Fore, deceased, on October 30, 1969, Recorded in the R.C. Office of Greenville County, State of South Carolina, in Book 928, Page 156.

NO residence to cost less than \$5,000.00 shall be erected on said lots; no residence shall be erected on any lot nearer than 35 feet to the front line; no residence shall be erected on any lot unless said lot has 50 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

This conveyance is subject to all easements and right-of-ways.
