Hood, Block A., according to a plat thereof prepared by C. O. Riddle dated October 20, 1967, and recorded in the R. M. C. BEGINNING at an iron pin on the Eastern side of Cunningham Road, at the joint front corner of Lots 4 and 5 and running thence with the joint line of said lots N. 85-59 E. 191.6 feet to an iron pin at the joint rear corner of Lots 4 and 5; thence with the rear line of Lot #4 S. 11-06 E. 96 feet to an iron pin at the joint rear corner of Lots 3 and 4; thence with the joint line of said lots S. 80-20 W. 198.5 feet to an iron pin on the Eastern side of Cunningham Road, joint front corner of Lots 3 and 4; thence running with Eastern side of Cunningham Road N. 7-00 W. 115 feet to the point of beginning.
