ALL that piece, parcel or lot of land situate on the North side of Riverdale Drive, near the City of Greenville, Greenville County, South Carolina, shown as Lot #30 on a Plat of Riverdale, prepared by Dalton & Neves Engineers, July, 1957, and recorded in the R.M.C.
