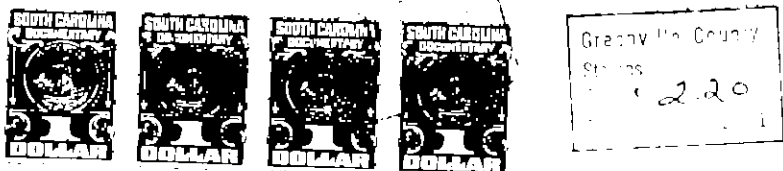
An undivided one-third (1/3) interest in and to all that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the easterly side of the intersection of Foxcroft Road and Stonehedge Drive, near the city of Greenville, S. C., being known and designated as Lot No. 56, on plat of Foxcroft, Section I., as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Stonehedge Drive, said pin being the joint front corner of Lots 56 and 57 and running thence on the northerly side of Stonehedge Drive S 86-11 W 100 feet to an iron pin at the intersection of Foxcroft Road and Stonehedge Drive; thence N 55-06 W 39 feet to an iron pin on the easterly side of Foxcroft Road; thence with the easterly side of Foxcroft Road N 16-22 W 144 feet to an iron pin, the joint corner of Lots 55 and 56; thence N 86-11 E 161.7 feet to an iron pin, the joint rear corner of Lots 56 and 57; thence with the common line of said lots S 3-49 E 165 feet to an iron pin, the point of beginning.
