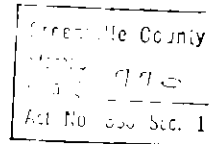
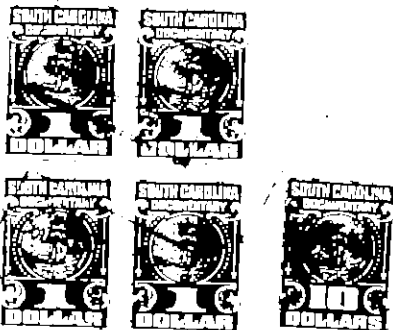

M. C. Office for Greenville County, in Plat Book WW, at Page 45, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Aberdare Court at the joint front corner of Lots 115 and 117, and running thence with the common line of said Lots N. 71-38 E. 146.5 feet to a point; thence S. 16-56 E. 210.0 feet to a point at the joint rear corner of Lots 117 and 120; thence with the common line of said lots N. 68-39 W. 161.8 feet to a point at the eastern side of Aberdare Court; thence with the curve of the said Court the chords of which are, N. 19-58 W. 25 feet, N. 38-24 W. 61.4 feet, and N. 17-35 W. 24.3 feet, to the point of beginning.

This conveyance is made subject to such easements, rights-of-way and restrictions of record or as appear on the premises.
