All that piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot 1, Block E, of a subdivision known as Carolina Court as shown on plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book F, at Page 96, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at a sharp bend in Eastlan Drive at a point formerly the northeast corner of Wickliffe Street and Buena Vista Avenue, and running thence along the east side of Buena Vista Avenue, N. 36-13 E. 103 feet to an iron pin on the right-of-way of C & W C Railway; thence along the line of said right-of-way, S. 65-43 E. 101.3 feet to an iron pin at the rear corner of Lot No. 2; thence along the line of that lot, S. 35-05 W. 122 feet to an iron pin on the north side of Eastlan Drive (formerly Wickliffe Street); thence along the north side of Eastlan Drive, N. 54-55 W. 101.3 feet to the beginning corner; being the same conveyed to me by Fred M.
