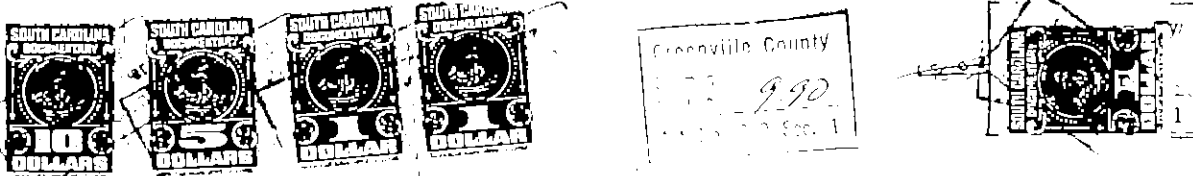

BEGINNING at an iron pin on the northwesterly side of Castlewood Drive, said pin being the joint corner of Lots 56 and 62 and running thence N 59-18 W 188.7 feet to an iron pin, the joint rear corner of Lots 61 and 62; thence with the common line of said Lots S 27-48 W 175.6 feet to an iron pin on the northeasterly side of Chippendale Drive; thence with the northeasterly side of Chippendale Drive S 62-12 E 109.3 feet to an iron pin at the intersection of Chippendale Drive and Castlewood Drive; thence N 81-52 E 40.5 feet to an iron pin on the northerly side of Castlewood Drive; thence with the northerly side of Castlewood Drive N 47-01 E 85.6 feet to an iron pin; thence continuing with said Drive N 44-09 E 63.8 feet to an iron pin, the point of beginning.
