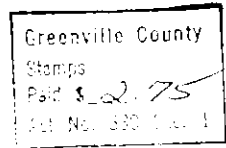
in consideration of Twenty-five Hundred (\$2500.00) Dollars,

Beginning at an iron pin on the east side of Carriage Drive, the joint front corner of Lots Nos. 50 & 51; thence with the joint line of said lots S. 87-00 E. 150 feet to an iron pin; thence N. 3-00 E. 80 feet to an iron pin corner of Lot No. 49; thence with the line of said lot N. 87-00 W. 150 feet to an iron pin on the east side of Carriage Drive; thence with the east side of said Street S. 3-00 W. 80 feet to the beginning corner.
