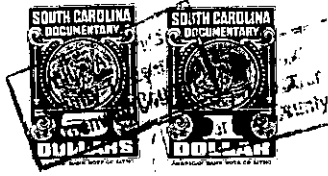

BEGINNING at an iron pin on the northwesterly side of Castlewood Drive, said pin being the joint front corner of Lots 73 and 74 and running thence N 58-07 W 147 feet to an iron pin, the joint rear corner of Lots 74, and 75; thence with the common line of said lots S 23-25 W 167.5 feet to an iron pin on the northerly side of Continental Drive; thence with the northerly side of Continental Drive S 58-40 E 43 feet to an iron pin; thence S 57-04 E 100.6 feet to an iron pin at the intersection of Continental Drive and Castlewood Drive; thence N 70-51 E 30.7 feet to an iron pin on the northwesterly side of Castlewood Drive; thence with the northwesterly side of Castlewood Drive N 16-44 E 45.9 feet to an iron pin; thence continuing with said Drive N 15-46 E 103.1 feet to an iron pin, the point of beginning.
