KNOW ALL MEN BY THESE PRESENTS, that J. C. Howard and Gladys B. Howard--

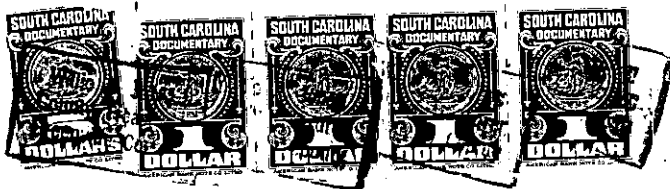
in consideration of Four Thousand, Five Hundred and No 100 (\$4,500.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Roy B. McMillan and Betty C. McMillan, for and during the terms of their natural lives and upon the death of either, unto the survivor thereof, his or her heirs and assigns, absolutely and forever,

ALL that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina, about one mile east of Double Springs Baptist Church, on the south side of the road that leads from Double Springs Church to and by Milford Church, and having the following courses and distances, to-wit:

BEGINNING at an iron pin in the center of the road above mentioned and running thence with the said road S. 86-00 W. 100 feet to an angle; thence with the center of the road N. 88-35 W. 251 feet to an iron pin in said road; thence with a line S. 7-10 E. 97 feet to an iron pin in pasture land; thence S. 22-30 W. 562 feet to an iron pin on the bank of the creek; thence down said creek as the line S. 56-30 E. 195 feet to a bend; thence S. 84-15 E. 220 feet to an iron pin on the bank of the creek; thence N. 12-50 E. 766 feet to the beginning corner and containing six (6) acres, more or less, this being identically the same property conveyed to Grantors by deed recorded in Deed Book 810, Page 43.

This conveyance is subject to all restrictions, setback lines, roadways, easements and rights-of-way, if any, appearing of record, on the premises or on the recorded plat, which affect the property hereinabove described.
