All that certain piece, parcel or lot of land situate, lying and being  
in the State and County aforesaid, lying on the north side of a County  
Road which leads off of the Jordan Road and being a part of tract No. 4  
4 as shown on Plat of W. T. Henson Estate made by W. P. Morrow, Surveyor,  
March 1930, and having the following courses and distances, to wit:-

Beginning on a stake in the said County Road, the same being a joint  
corner of Naomi R. Atkins tract, and run thence N. 84-00 W. 742.0 feet  
to a stone corner; thence S. 38-30 E. 395.6 feet to a stake in the  
said road; thence with the said road N. 61-05 E. 252 feet to a point in  
said County Road; thence N. 66-42 E. 461 feet to the beginning corner.

The purpose of this deed is to make the said County Road the dividing  
line of the property of the grantor and the grantee herein.
