All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 48, Plat of Belle Meade, which plat is recorded in the RMC Office for Greenville County, S.C. in Plat Book EE, pages 116 and 117, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southwesterly side of Williamsburg Drive, said pin being the joint front corner of Lots 34 and 48 and running thence along the common line of said lots N 78-11 W 86.2 feet to an iron pin, joint corner of lots 34, 35 and 48; thence N 3-42 W 112.6 feet to an iron pin, joint rear corner of lots 47 and 48; thence along the common line of said lots S 78-27 E 115.9 feet to an iron pin on the southwesterly side of Williamsburg Drive; thence with the southwesterly side of said Drive S 11-33-W 109 feet to an iron pin, the point of beginning.
